- CATEGORY 3 INSPECTION LICENSE: **\$180.00**  
(Trucks over 17,000 pounds and trailers over 10,000 pounds and buses)  
A CDL is not required to earn this license
- CATEGORY 4 ENHANCED INSPECTION LICENSE: **\$60.00** (standalone testing)

- ADDITIONAL CATEGORY 2 INSPECTION LICENSE: **\$60.00**  
(Motorcycles, vehicles that do not travel on more than 3 wheels)
- ADDITIONAL CATEGORY 3 INSPECTION LICENSE: **\$60.00**  
(Trucks over 17,000 pounds and trailers over 10,000 pounds and buses)

**TERMS AND CONDITIONS:**

New Castle School of Trades reserves the right to make any changes in the schedule of hours or dates.

Upon completion of the class, the student will be required to pass a 30 question **BASELINE TEST** with a minimum score of 70 percent. Failure to meet the 70 percent minimum will require the student to retake the entire course at full cost to the student.

Upon completion of the class, the student will be required to pass a 20 question **CATEGORY 1 TEST** with a minimum score of 70 percent. Failure to meet the 70 percent minimum will require the student to retake the **CATEGORY 1 TEST** at the established fee.

After meeting the 70 percent minimum requirement on both the **BASELINE TEST** and the **CATEGORY 1 TEST**, the student will be required to pass a **TACTILE TEST** with a 100 percent rating. Failure to meet the 100 percent rating on the **TACTILE TEST** will require the student retake to the **TACTILE TEST** at the established fee.

***THE STUDENT WILL NOT BE ADMITTED TO ANY CLASS WITHOUT PHOTO IDENTIFICATION.***

**THE STUDENT MUST ATTEND ALL CLASSES.**

**AN ENROLLEE MAY CANCEL HIS OR HER ENROLLMENT UP TO THREE (3) DAYS PRIOR TO THE START OF CLASS FOR A FULL REFUND. FAILURE TO CANCEL PRIOR TO THREE (3) DAYS BEFORE THE START OF CLASS WILL RESULT IN THE LOSS OF THE ENTIRE COST OF THE CLASS.**
